**COMPANY LICENSE CHECKLIST**

- Answer all questions on the application.
- Provide a copy of your current vehicle registration.
- Provide a current insurance certificate showing the City of Portland listed as an additional insured. Please follow the Insurance minimums set by the State of Maine.
- New meter seal report
- Provide a copy of your valid Maine Driver's License.
- Vehicle inspection report\*
- Payment of \$360 (New) or \$350 (Renewal) for 1 vehicle. Add \$315 for each additional vehicle.
- \$21 for each administrative person not applying for a taxi driver's license (e.g. owner/manager).

**DRIVER LICENSE CHECKLIST**

- Answer all the questions on the application.
- Provide **two 2"x2"** full face color photos meeting the requirements listed on the application. No hats or sunglasses.
- Photocopy of your valid Maine Driver's License.
- Payment for **Taxi Driver** of \$145 (New) or \$135 (Renewal) or
- Payment for **Livery Driver** of \$87 (New) or \$77 (Renewal) or
- Payment for **Tour Driver** of \$98 (New) or \$88 (Renewal).

**\*Vehicle Inspections**-Parking for an inspection will be in the reserved taxi parking lot, next to the ground transportation booth at the Portland Jetport, 1001 Westbrook Street, Portland, Maine. Hours are 9:00am-4:00pm Monday thru Friday.
