**ORDER DECLARING SATURDAY AND SUNDAY, AUGUST 16 AND 17, 2014,
AS "89TH ANNUAL ST. PETER'S BAZAAR AND
ITALIAN STREET FESTIVAL"
AND APPROVING FRIDAY, AUGUST 15, 2014, AS "ST. PETER'S
4-MILE ROAD RACE"**

ORDERED, that Saturday, August 16, and Sunday, August 17, 2014, are hereby declared "89th Annual St. Peter's Bazaar and Italian Street Festival"; and

BE IT FURTHER ORDERED, that the St. Peter's 4-Mile Road Race is approved for 7:00 p.m., Friday, August 15, 2014, with the closing of India Street from Federal to Fore Streets for the start of said Race from 6:55 to 7:10 p.m.; and

BE IT FURTHER ORDERED, that Federal Street from India Street to Franklin Street shall be closed to vehicular traffic on Friday, Saturday and Sunday, August 15, 16 and 17, from Noon to Midnight of each day and shall be posted "No Parking"; and

BE IT FURTHER ORDERED, that the Festival area is closed to street vendors pursuant to Sec. 19-17 of the City Code; and

BE IT FURTHER ORDERED, that the City Manager is authorized to issue a revocable permit under Sec. 25-27 of the City Code to St. Peter's Church for use of the above described area for the Festival, subject to the following conditions:

- The St. Peter's Festival organizers shall be solely responsible for trash cleanup at the festival and shall be required to leave a Park Security Deposit (amount determined by the Public Services Director or designee) on file at the Public Services Event Office; and
- St. Peter's Church shall be responsible for any costs incurred by city departments for the purposes of facilitating the Festival, Road Race, banner hanging, including but not limited to, police department charges, public services fees, parking control fees, inspection services fees, city clerk's license fees and public services event office fees and shall adhere to conditions for use as stated in the permit for use issued by the Public Services Event Office; and

- Under no circumstances may alcoholic beverages be sold or consumed on the streets or public property of said area during said festival; and
- The St. Peter's Festival organizers shall have sole authority over participating vendors at the event and may charge a fee to vendors for the opportunity to vend at the Festival; and
- Conditions for use of grounds and requirements for food service, vending sales, concert licensing, tent and stage installations, and other items specified in a permit issued from PS Event Office, shall be adhered to; and
- The St. Peter's Festival organizers shall indemnify the City and hold it harmless from and against all claims arising out of activities during said Festival, and shall take out and maintain public liability insurance coverage in the amount of at least **\$400,000** combined single limit for personal or bodily injury, death or property damage for said purpose. This insurance certificate will also list the City of Portland as an additional insured in regards to the "St. Peter's Bazaar and Italian Street Festival" activities, and the City be endorsed on the policy; and

BE IT FURTHER ORDERED, that the City Manager is authorized to issue such other temporary licenses, including licenses for food service establishments, as may be required by the City Code, provided all other applicable requirements of the City Code have been met regarding the operation of said Festival and Road Race.
