**ORDER DECLARING SATURDAY, AUGUST 23, 2014, AS
“49th ANNUAL WCSH6 SIDEWALK ART FESTIVAL”**

ORDERED, that the 49th Annual WCSH6 Sidewalk Art Festival be and hereby is declared on Saturday, August 23, 2014 or, in the event of rain, on Sunday, August 24, 2014; and

BE IT FURTHER ORDERED, that the Festival area shall be Congress Street (the street itself), sidewalks and squares, from High Street to Elm Street (Monument Square) and Oak, Casco, Brown, Center and Preble Streets that connect with Congress Street; and

BE IT FURTHER ORDERED, that the Festival area shall be closed to traffic from 6:00 a.m. to 6:00 p.m. on Saturday, August 23, or the rain date, except High Street shall remain open; and

BE IT FURTHER ORDERED, that a parking ban is hereby authorized beginning Friday, August 22, 2014 at 6:00 p.m. through 6:00 p.m. Saturday, August 23, 2014. In the event the Festival is postponed from August 23 to August 24, the parking ban shall occur twenty-four (24) hours later than stated above; and

BE IT FURTHER ORDERED, that said parking ban shall be on both sides of Congress Street from High Street to Elm Street, including side streets (Oak, Casco, Brown, Preble and Center Streets for one block);

- Vehicles in violation of the “no parking” signs in the Festival Zone (interior roadways) shall be towed at owners’ expense; and

BE IT FURTHER ORDERED, that the Festival area will be closed to street vendors and artists pursuant to Section 19-17 of the Portland City Code and is reserved the use of WCSH6, for the purpose of conducting the Festival, subject to the direction and control of the City Manager; and

BE IT FURTHER ORDERED, that the City Manager is authorized to issue a revocable permit under Sec. 25-27 of the Portland City Code to WCSH6 for use of the above described area for the Festival, subject to the following conditions:

- Under no circumstances may alcoholic beverages be sold or consumed on the streets or public property of said area during the Festival; and
- WCSH6 shall be responsible for reimbursing the Police Department for services, the Public Services Department for services, and the City Clerk's Office for licenses; and
- The WCSH6 Sidewalk Art Festival organizers shall be solely responsible for trash cleanup at the Festival and shall be required to leave a Park Security Deposit (amount determined by the Public Services Director or designee) on file at the Public Services Event Office; and
- The WCSH6 Sidewalk Art Festival organizers shall have sole authority over participating vendors at the event and may charge a fee to vendors for the opportunity to vend at the Festival; and
- Conditions for use of grounds and requirements for food service, vending sales, concert licensing, tent and stage installations, and other items specified in a permit issued from Public Services Event Office, shall be adhered to; and
- The WCSH6 Sidewalk Art Festival organizers shall indemnify the City and hold it harmless from and against all claims arising out of activities during said Festival, and shall take out and maintain public liability insurance coverage in the amount of at least **\$400,000** per occurrence for personal or bodily injury, death or property damage for said purpose. This insurance certificate will also list the City of Portland as an additional insured in regards to the “WCSH6 Sidewalk Art Festival” activities, and the City be endorsed on the policy; and

BE IT FURTHER ORDERED, that the City Manager is authorized to issue such other temporary licenses, including licenses for food service establishments, as may be required by the Portland City Code, provided all other applicable requirements of said Code have been met regarding the operation of the Festival.
